ORDER

The Government of Madhya Pradesh has sent a proposal vide their letter no. E-1/464/2015/5/l dated 01.02.2017 for fixation of seniority / assigning the year of allotment to the one officer viz Shri Virendra Singh Rawat appointed to IAS from State Civil Service on the basis of inclusion of his name "**Unconditional**" by UPSC in the **Select List of 2015**.

2. The seniority/year of allotment of IAS officer appointed on the basis of **Select List of 2015** has already been fixed seniority vide order of even number dated 11.07.2016. Seniority /year of allotment of Shri Virendra Singh Rawat could not be fixed alongwith other officers, as he was provisionally included in the select list of 2015 subject to clearance in the disciplinary proceedings pending against him and grant of integrity certificate by the State Government. Subsequently inclusion of his name in the said select list was declared unconditional by UPSC on a proposal from State Government. Consequently Shri Virendra Singh Rawat was appointed to IAS vide Notification No. 14015/13/2016-AIS-(I) B dated 13.01.2017.

3. From Notification No. 14015/13/2016-AIS-(I) A dated 01.07.2016, it has been observed that Shri Virendra Singh Rawat at Sl. No.11 included below Urmila Surendra Shukla at Sl. No. 10 and above Shri Alok Kumar Singh at Sl. No. 12 in the Select List of 2015..

4. In view of the above, the seniority/year of allotment of above officer has been considered and computed under Rule 3(3) (ii) of IAS (Regulation of Seniority), Rules 1987, and other relevant Rules as amended from time to time. Weightage formula is as under:-
