2. Ministry of Petroleum & Natural Gas is requested to send a copy of order relieving Sh. Nalin Kumar Srivastava, (ICAS: 2001), for the assignment along with a copy of terms and conditions of the said assignment, to this Department for information and records.

It may also be noted in this regard that the deputationist officer is deemed to have been relieved on the date of expiry of the deputation period unless the competent authority has with requisite approvals, extended the period of deputation, in writing, prior to its date of expiry. In the event of the officer overstaying for any reason whatsoever, he/she is liable for disciplinary action and other adverse Civil/Service consequences which would include the period of overstay not being counted for service for the purpose of pension and that any increment due during the period of overstay being deferred with cumulative effect, till the date on which the officer rejoins in his parent cadre. Proceedings for deemed resignation from service would also be initiated. This may be brought to the notice of the officer.
